

LAST WILL AND TESTAMENT OF Peter Miller

I, Peter Miller

I, being of sound mind and body do hereby declare that this document is my last will and testament.

FIRST. I revoke all former wills and codicils that I have previously made.

SECOND. I give, devise, and bequeath all of my estate to my Husband :

THIRD. In the event that my spouse shall predecease or fail to survive me by thirty (30) days, I wish for my assets to be distributed the following way :

my son Henry Miller will recieve:  
all my properties in the city of Dallas

my daughter Emily Miller will receive:  
my country home in the city of West Palm Beach FLA

My wife Dorothy Miller Smith will receive:  
a life insurance policy of 1,000,000 and an annuity (lifetime) of \$250,000 per year

FOURTH . If any beneficiary herein shall be under the age of twenty one, (21) years at the time of my death then, and in that event, I give, devise, and bequeath his/her, their share(s) to by trustee named hereinbelow, in TRUST nevertheless to hold, invest, and reinvest the principal or corpus of the trust and thereafter pay the principal or corpus of the trust plus any accumulated income to the aforesaid beneficiary upon his/her attaining the age of TWENTY ONE (21) years. My trustee, My wife Dorothy Miller Smith may in his/her discretion, pay over to, or apply the net income of the trust of any beneficiary who has not attained that age, or accumulate for addition to principal any part of the income which is not so distributed. I also empower my trustee, in his/her discretion, to pay over any part or all of the principal of said trust, for the benefit of said beneficiary, for his/her support, education and maintenance, including medical, surgical, hospital or other institutional care, the quality of which I leave to my trustee's discretion.

HOWEVER, in the event that the above person or persons

predeceases me, I give that same money or personal property to his or her surviving beneficiaries. If there are no surviving beneficiaries, this money or personal property shall go to those persons who can inherit each receiving an equal portion, All in Accordance with the laws of the State of Texas.

FIFTH. I direct that all inheritance, estate, other death taxes , or any other required taxes shall be paid by my Executor out of the residue of my estate disposed of by this Will, without adjustment among the residuary beneficiaries, and shall not be charged against or collected from any beneficiary of my probate estate, or from any transferee or beneficiary of any property outside my probate estate.

SIXTH. I nominate My Husband :, as Executor of this Will, to serve without bond. If he/she shall for any reason fail to qualify as Executor, I nominate Henry Miller, as Executor to serve without bond. If Henry Miller shall for any reason fail to qualify as Executor, I nominate Emily Miller, as Executor to serve without bond.

SEVENTH. I hereby empower my Executor to sell property, real or personal, for cash or on time, without an order of Court, at such time and upon such terms and conditions as shall seem best.

EIGHTH. I hereby nominate, constitute, and appoint My wife Dorothy Miller Smith ,Guardian of the person and property of any infants named herein to serve without bond
